**Eligibility.** The Dr. Marc Taylor Environmental Stewardship Award is open to any individual in the State of Connecticut except as specified below. **Agreement to Rules.** Participation in the Dr. Marc Taylor Environmental Stewardship Award constitutes the nominator's and nominee's full and unconditional agreement to the Official Rules and Sponsor's decisions, which are final and binding.

**Entry.** To participate, the official nomination form found at www.pomperaug.org must be completed and submitted with any supporting materials online or received in the mail by 11:59 p.m. EDT on July 20, 2018.

**Use of Award Winner Name.** Each winner that accepts any award will be deemed thereby to have granted to Sponsor the right, at any time and from time to time, to print, publish, broadcast and use, in any media now known or hereafter developed, the award winner's name and town/city. Winner may also be requested, after receiving their award, to participate in further promotional activities. Participation in such activities (other than the promotional release of award winner name and town/city) is not a condition of participation in the Dr. Marc Taylor Environmental Stewardship Award Program.
